

## **Ordinance of the County Board of Kankakee County, Illinois**

### **AMENDED**

**RE: COMBINED ANNUAL BUDGET AND APPROPRIATION ORDINANCE FOR  
KANKAKEE COUNTY, ILLINOIS 2016 FISCAL YEAR INCLUDING THE  
KANKAKEE COUNTY HEALTH DEPARTMENT**

**WHEREAS**, the Kankakee County Board, at its November 30th, 2015, meeting reviewed, considered and determined the amounts of monies estimated and deemed necessary to meet and defray all the legal liabilities and necessary expenses to be incurred by November 30, 2016 and passed the fiscal year 2016 budget.

**WHEREAS**, at the Finance Committee Meeting of October 20, 2016 has recommended an amended budget for fiscal year 2016 and listed a specific detailed statement for the Kankakee County Health Department to reflect the budgeted and itemized county expenditures for the Kankakee County Health Department.

**WHEREAS** by the Kankakee County Board, that the 2016 fiscal year begins December 1, 2015 and will end November 30, 2016 and the amendment to the budget includes changes to the budget for the Kankakee County Health Department as amended.

**NOW, THEREFORE, BE IT ORDAINED** by the Kankakee County Board that the attached recommended budget amendment to include amendment to the Kankakee County Health Department budget be adopted and appropriated as the Amended Combined Annual Budget and Appropriation Ordinance of Kankakee County and to reflect the changes in the Kankakee County Health Department budget for the fiscal year beginning December 1, 2015, and ending November 30, 2016.

**NOW THEREFORE, BE IT FURTHER ORDAINED** by the Kankakee County Board that the amounts listed as budget amounts for the fiscal year from December 1, 2015, through November 30, 2016, for Kankakee County in the attached amendment of the Combined Annual Budget herein adopted by and the same are hereby appropriated for the purposes herein specified, or so much thereof as may be authorized by law. Supporting documents are made a part of this ordinance and incorporated herein by reference. (attached as exhibit A)

**NOW THEREFORE, BE IT FURTHER ORDAINED** that the budget and appropriation changes as reflected in Exhibit B for the Kankakee County Health Department herein made and ordained be known as the Amended Combined Annual Budget and

Appropriation Ordinance for Kankakee County, State of Illinois, for fiscal year 2015-2016 to include the Kankakee County Health Department.
